

## Corporate Card Online Account Request Instructions

It is necessary to have your **Employee ID**, **Delegate of Authority (DOA, also your Department Administrator)**, and Office Address available prior to completing the application. The DOA will confirm the business justification and approval for card. Each application will then be reviewed by the Card Administrator to ensure the applicant meets the qualifying criteria to hold a Corporate Card. Upon completion, Bank of America will send the Corporate Card directly to the applicant's office address.

Don't know your DOA? You can find this by logging into Employee Self Service (ESS) on the BCM Intranet.

- Go to intranet.bcm.edu, click Self Service > Employee Self Service > Open ESS
- Go to the BCM tab once logged into ESS and click "Who is My DOA?"



Note: The Corporate Card online account request process is only for **new** card applications and is not to be used for lost/stolen or replacement cards. **Desired Credit Limit:** Credit limits <u>are linked to career streams and DPP levels</u>. If you have not been through DPP yet, the spending limit will be adjusted when you receive your leveling, if appropriate.

- •DPP levels S1 P2 can request profile 1 or profile 2, monthly credit limit \$5K with single transaction limit \$2,500 or up to monthly credit limit \$10K with single transaction limit \$3,500 based on role and business need only
- •DPP levels P3 M5, and Faculty (F) will have profile 3, monthly credit limit up to \$15K with single transaction limit \$4,500

## After Your Online Account Request is completed:

You must review the <u>Use of Corporate Travel Card/Roles & Responsibilities</u> and sign the <u>Corporate</u> <u>Travel Cardholder Agreement</u> and send to the card administrator for your application to be completed. This form is required in order to process the card application.

In the mean-time the card request will route to your specified DOA in an email asking for approval. The email will come from <u>worksnoreply@works.com</u>. It is your DOA's responsibility to follow the instructions of the email and forward with an approval or rejection to the card administrator, at <u>cardadmin@bcm.edu</u>. If your DOA does not approve, you will receive an email notification and your application will be deleted.

You will receive email confirmation of the following milestones:

- Application submitted
- Application approved or rejected
- Application status (e.g., missing sign agreement form)
- Welcome email (confirming completed application)



## Receive and Activate Your Corporate Card:

After the card number is created, it can take up to three weeks to receive your card. The card is sent via mail. The card will arrive to the Baylor business office address that you specified in your application and will require a signature for delivery.

Please activate your new card according to the instructions on the card and attached letter. To activate your card, you will need both your custom verification code and the phone number from your application.

During the activation call, you will be able to set up your custom pin number (this is your 4 digits #, not your verification/activation code). If you do not remember the information you need to activate your card, please contact the card administrator at <u>cardadmin@bcm.edu</u>.
